The jury will be appointed by 15. 5. 2018. The 3/5-member jury will be appointed by the ministries of the participating countries.

Conditions and instructions for cooperation:

- Participation is possible by everyone who has covered obligations towards their country and is not bankrupt
- The winners from past years cannot apply with the same project awarded by the **Bled Water Festival**
- In the case of incomplete application, you will be invited to complete it.
- In four days after the confirmation of your application, you will receive a confirmation e-mail stating that your application is received. With this confirmation, you are included in the competition part.
- On 1.6.2018 all participants will receive an e-mail with the shortlist of winners.
- We will choose three nominees from each category and invite them to Bled (8.6.2018 – Friday).
- The organizer does not cover any expenses related to the award receiving or similar
- The nominees are obliged to come to the award ceremony or send someone to take the award on their behalf on 8.6.2018 in Bled (Slovenia).
- If the award shall be sent via post, the addressee (winner) covers the shipping costs.
- According to the previous agreement, the organization Bled Water Festival can enable a presentation of the products/services of all nominees at the location (free of charge). However, please consider that there are some spatial and fitting limitations due to which certain presentations cannot be realized.
- All winners are obliged to cooperate further with the Bled Water Festival platform at their best (the winners will be invited to round tables, lectures, solving problems with their solutions, etc.)
- After your application, the organizer has the right to publish all data, which can be found under »public announcement« in the application form.
- A video clip or photo material of your products/services is welcome (they can be delivered to our e-mail address or via wetransfer.com). All material will be publicly available.
- If the data, photo/video material is confidential, please state that the material is confidential; the organization Bled Water Festival will consider them as such.
- The organizer has the right to increase the number of the jury members if there will be more applicants than planned.
- If you state the size of your company incorrectly, you will be disqualified.
- If the finalists would like to attend the Bled Water Festival for 2 days, our organization can provide the all-access accreditation. In this case, please inform us until 1.6.2018 (24:00 CET).
